**Background:** 

Board Inquiry (November): Are there School Divisions in Saskatchewan using 15 passenger vans? Is there data regarding whether or not 15 passenger vans are unsafe?

**Current Status:** 

Are school divisions using 15 passenger vans? 11 rural school divisions (similar to ours) were polled to determine if they currently use 15 passenger vans and, if so, are there any conditions/restrictions associated with using the vans. A summary of the results are below: Individual school division data is also attached.

- 8 school divisions currently use 15 passenger vans (safety restrictions in place)
- 3 school divisions do not but one division has also been asked to investigate

#### What does current research state?

In June 2010, Transport Canada announced that it would review the safety of vans used for student transportation. This review was to include consultations with provincial and territorial governments, an assessment of the safety and stability of extra-curricular activity vehicles, brake testing and testing to determine the vehicle rollover threshold. A summary of the results are included below. Phase 1 involved crash avoidance tests {7 vehicles were used in the test: a 7-passenger minivan, a 12 passenger van, two 15 passenger vans, a 19-seat mini school bus, a 30-seat mini school bus, and a 21-seat Multi-functional Activity Bus (MFAB)}

### Results:

The 15-passenger vans that were tested performed as well as and sometimes better than the two school buses and the MFAB in all Phase 1 tests performed (page 31 – Evaluation of 15-Passenger Vans prepared by Canadian Council of Motor Transport Administrators AND page 4 – Investigations – Transport Canada)

Phase 2 involved dynamic manoeuvre testing (3 vehicles were tested: two 15 passenger vans and a MFAB.

### Results

- Vehicles with ESC could perform Sine with Dwell Manoeuvre at 80 and 100 km/h in nominal and full load conditions without spinning out.
- The two 15-Passenger vans with ESC activated were capable of completing the fishhook manoeuvre at nominal and full load, even with the rear tire pressure reduced from 80 psi to 50 psi
- The fishhook manoeuvre in the full load condition was performed on the MFAB at a speed of 55 km/h with a tire pressure of 50 psi and at 65km/h with a tire pressure of 80 psi. It resulted in spinning out. Without the outrigger equipment, the vehicle would have rolled.
- Without ESC none of the vehicles was able to complete the fishhook manoeuvres
   Page 60 Evaluation of 15-Passenger Vans prepared by Canadian Council of Motor Transport Administrators

Phase 3 involved paired side impact crash testing of a 15 passenger van & a MFAB

### Results

- The outcome of this paired crash testing is comparable to other side impact crash tests that have been previously conducted with passenger vehicles.
- Transport Canada does not draw general conclusions concerning the crashworthiness of 15 passenger vans nor the MFAB types of vehicles. (page 28 – Transport Canada Paired Side Impact Crash Testing of a 15 Passenger Van & a MFAB)

Evaluation of 15-Passenger Vans prepared by Canadian Council of Motor Transport Administrators Final Recommendation

• Research does not support a ban of 15-passenger vans in Canada regardless of their use. ... Fifteen passenger vans meet all federal manufacturing requirements/standards, and testing has demonstrated that they are not less stable or more prone to roll over than other vehicles with similar capacities... and research has shown that driver training and proper maintenance can improve driver knowledge and skill level as well as the handling and performance of 15-passenger vans.

What is SSBA's view on 15 passenger vans?

In 2006, SSBA came out with the following memorandum regarding 15 passenger vans. Dave Jackson states that SSBA's position has not changed since that time but states that 15 passenger vans "can be utilized if proper risk management process are followed."

The Saskatchewan School Boards Association maintains the position that 15 passenger vans are a higher risk vehicle because of difficulty with handling at highway speeds, weight and balance problems, lack of proper driver instruction, and an increased propensity for rollover accidents.

SGI recommends the use of school buses for transporting students to and from school or to extra-curricular activities.

#### **Pros and Cons:**

#### Pros:

- ...it provides a wider range of transportation options for schools.
- ...15 passenger vans can be more economical than a school bus.
- ...post-2011 vehicles are safer than pre-2011 vehicles because of requirements related to electronic stability control.

### Cons:

- ...the motion would allow 15 passenger vans to be driven by anyone with a class 5 driver's licence with no additional oversight.
- ...it is a knee-jerk reaction to budget adjustments that may not consider other appropriate options.
- ...fewer drivers means lower levels of parent engagement in extra-curricular activities.
- ...we have zero control over vehicle maintenance and limited control over driver practices
- ...15 passenger vans are less familiar to many volunteer drivers than their own personal vehicles are.
- ...school bus is recognized as the best student transportation option

## **Evidence**

### **Background:**

#### Prekindergarten

Prairie South has been very active in supporting the development of both Ministry funded and Prairie South funded Early Learning Programs. Prekindergarten is a developmentally appropriate educational program, founded on early childhood research and practice:

- Active, experiential learning through play
- Comprehensive, integrated program within a prepared environment
- Child-centred, self-directed, offers choice, includes physical, intellectual and spiritual development
- Meaningful family engagement
- Active parent/community council, community partnerships and shared ownership
- Integrated health, social services and educational supports
- Culturally responsive for all
- Mixed age groupings
- Intensive exposure minimum 12 hours per week
- Professional teaching staff with a focus in early childhood

The Ministry determines where a funded program will be established based on census data, and access to other high quality programs in the neighborhood.

Ministry funded programs have a set of criteria that students must meet in order to be eligible to participate. The criteria are based upon access to other quality programming, low income, single parent,

and referral from another agency, isolated home, communication/language delays, social, emotional or behavioural difficulties, mother's mental health, family abuse/neglect and other criteria. Parents complete an application and the Prek teacher does a home visit to further discuss the criteria and then decides who will gain entry into the program.

Programs that are funded through Prairie South and the Ministry both receive support services from the Learning Department:

- Early Learning Consultant
- Speech and Language Pathologist
- Support from Psychologists and Learning Consultants vary depending on the needs of the students.

The Learning Department does not provide support to children in the Palliser Heights Early Learning Center or the Coronach Early Learning and Literacy Center as children at those centers access services from the Health Region.



### Prekindergarten Application for Prairie South Funded Programs – Information for Parents

Prairie South is pleased to be able to offer Prekindergarten programs that are funded through Prairie South, indicating Prairie South's strong belief in the value of high quality early learning programs for 3 and 4 year olds. The focus of the program is not for children to learn numbers and letters or to learn to read but to expose them to language, literacy and numeracy through a play based approach. Although the program is not funded through the Ministry the program follows Ministry guidelines.

The application process for Prairie South funded programs is different than for Ministry funded programs. It is important for parents to understand that being first in line does not guaranteed a spot in a program. When the application process ends all of the applications are looked at and class groupings are determined based on:

- 1. Being at least 3 years old by the first day of school and must be potty trained
- 2. 3 year olds currently in the program will be placed first if requested by parent
- 3. Registration in catchment area or boundary exemption applied for
- 4. Any diagnosed learning needs or referral from another agency such as Health
- 5. Having a language other than English as the first language
- 6. A preference of 4 year olds
- 7. Having a balance of boys and girls

Parents must apply within their catchment area or the area in which they will be seeking a boundary exemption for (this generally occurs due to babysitting reasons). If the program in your catchment area is full and others in the city are not full, parents may be offered a spot in another program. If they accept the spot they must be willing to provide their own transportation.

Transportation within catchment is available but must be requested by filling out a transportation request form available at the school. Transportation to rural programs (Lindale, Assiniboia 7<sup>th</sup> Ave, Lafleche, and Coronach) will be provided one way only. Transportation to city programs may be provided both ways.


Each program will serve a maximum of 16 children and will be staffed by a Teacher and an Educational Assistant. Each program will hold back 1 or 2 spots until September in case a child with an intensive need arrives over the summer and requires a placement. If that does not occur then the final two spots may be filled early in September. Each school will maintain a waiting list and if a child moves during the year the child at the top of the waiting list will be offered the spot.

Parents are key partners in our Prek programs. The teacher will send home a schedule of Prek events as they develop and we strongly encourage parents to participate. Please contact the school principal if you have any questions about the information contained on this letter.

You will be notified by the school of your child's placement after the registration closes and some time is taken to develop the class lists. Thank you for your patience and cooperation, we are all very excited to be learning together!

### **Kindergarten**

The kindergarten teachers are also responsible for administering the Early Years Evaluation Teacher Assessment (EYE-TA) as mandated by the Ministry of Education each fall and certain select students are reassessed in the spring. In the fall of 2015, 483 Kindergarten students were assessed. The results of the fall 2015 administration are below.



Kindergarten teachers also receive support from the Learning Department staff on an as requested basis. The Early Learning consultant provides support to the Kindergarten teachers and programs.

**Background:** 

Following direction from the Board of Education at the January 5, 2016 Board meeting the Caronport Elementary School SCC went through an information gathering. consultation process to determine the will of the Caronport Elementary School community to have recitation of the Lord's Prayer during opening activities and Religious Education in the last half hour of each day at the school. The Caronport Elementary School SCC is aware of and has accounted for guidelines set out in section 182 of The Education Act, 1995 for these activities. The Caronport Elementary School SCC sent a letter home to each Caronport Elementary School family asking them to consider what it meant to them to have the Lord's Prayer recited each day and to have Religious Education at school (see parent letter). From parent responses and SCC deliberation the SCC determined that it was the will of the Caronport Elementary School community to recite the Lord's Prayer during opening activities and to have Religious Education in the last half hour of each day. As a result the Caronport elementary School SCC has made a written request for the Board to direct recitation of the Lord's Prayer during opening activities and Religious Education in the last half hour of each day at Caronport Elementary School (see letter of request).

### Recommendation:

That the Board of Education in response to the Caronport Elementary School SCC request directs recitation of the Lord's Prayer during opening activities and Religious Education each day at Caronport Elementary School, in accordance with guidelines found in section 182 of The Education Act, 1995.

Dear Prairie South School Division Board of Trustees.

On behalf of the Caronport Elementary School Community Council, we would like to thank you for the opportunity to engage in a consultative process with the Caronport parents regarding the Lord's Prayer and Religious Education. After receiving direction to do so from the board in December, we sent home a letter to parents (see attached) requesting feedback on the daily recitation of the Lord's Prayer and Religious Education, both which have been practiced since Caronport Elementary's foundation over 70 years ago. The letters were colour-coded (green for Pre-K - Gr. 4; pink for Gr. 5-8) and asked parents to respond by sending the forms back to the school, thus preventing duplication. Alternately, parents were invited to email their responses to the SCCCES email account should they wish to do that instead of sending a note back.

Parents responded firstly with gratitude that they were able to engage in this worthwhile discussion and secondly with overwhelming positive, thoughtful responses that these two activities were indeed very important to keep at Caronport Elementary School. (There were a few respondents who said it was "unimportant" but one also included they had no issue if it continued) We were pleased at this overwhelming response, and happy that the tone of the responses demonstrated thoughtful and articulate comments about what these activities represent to their families and this community. Given the history of CES and its situation within this unique community there were also lots of ideas and suggestions included as to how to move forward even more effectively, especially regarding the Religious Education component.

For these reasons, we request that the Prairie South Schools Board of Education direct recitation of the Lord's Prayer during opening activities and Religious Education during the end of the school day at Caronport Elementary School as outlined in Section 182 of The Education Act, 1995.

Thank you for supporting our School Community Council through this process. We look forward to hearing your decision.

The Caronport Elementary School School Community Council has two important issues before us and we are asking for your immediate feedback. We deeply appreciate your thoughts and ask for a prompt reply. This is a significant opportunity for you to have a voice at Caronport Elementary School (CES).

Our students have also been taught a Christian Ethics program, the Saskatchewan Education Act formally refers to this as Religious Instruction. We are asking you, as a parent or guardian of a Caronport Elementary school student, to provide the CES School Community Council (SCC) with feedback regarding your will to continue with these practices.

Please answer the questions below by circling your response and we would encourage you to also tell us what you think of these practices by commenting. It is important for you to know that neither recitation of the Lord's Prayer or Religious Instruction cross any Human Rights issues but are protected in the Education Act. The link can be found on the digital copy of this letter on our school website. It is also important to know that this action is the second step in a four step process. Once we have heard your feedback, a determination will be made whether or not to move forward with a letter to the Prairie South School Division (PSSD) Board requesting official approval to continue these practices.

Thank you for your participation in this important process. We greatly value and appreciate your feedback.

# Tender Report for the period January 25, 2016 to February 21, 2016

### **Background**:

- Board has requested a monthly report of tenders awarded which exceed the limits of Administrative procedure 513, which details limits where formal competitive bids are required. The procedure is as follows:
  - The Board of Education has delegated responsibility for the award of tenders to administration except where bids received for capital projects exceed budget. In this case the Board reserves the authority to accept/reject those tenders. A report of tenders awarded since the previous Board Meeting will be prepared for each regularly planned Board meeting as an information item.
  - Competitive bids will be required for the purchase, lease or other acquisition of an interest in real or personal property, for the purchase of building materials, for the provision of transportation services and for other services exceeding \$75,000 and for the construction, renovation or alteration of a facility and other capital works authorized under the Education Act 1995 exceeding \$200,000.

### **Current Status:**

- There was one competitive bid awarded during this period.
  - Prairie South School Division entered into a joint tender with Prairie Spirit School Division and North East School Division for the purchase of school buses. The tender was awarded to Legacy Bus Sales of Saskatoon. Prairie South's portion of the tender was five 47 passenger buses and one 72 passenger bus for a cost of \$632,142 before taxes. The price this year was up significantly with the change in exchange rates between the Canadian and American dollars. We have to go back two years to find a purchase of buses close to the same size. The difference in cost between the current year's buses which are slightly larger and the buses purchased in the spring of 2014 is approximately 27%.

RE: Submission of Resolutions for the 2016 Spring Assembly AGM

The 2016 Spring Assembly will be held in Regina at the Hilton Doubletree on April 14 & 15, 2016. As discussed at the recent Members Council, the Executive has approved adding a business component to this year's Spring Assembly as a special circumstance in order to deal with a timely resolution being presented by the Aboriginal Constituency. The business portion at Spring Assembly to address this item is scheduled for April 15, 2016. The purpose of this memorandum is to remind boards of the resolutions process and to communicate deadlines for submission to the Committee for presentation by the Committee at Spring Assembly.

The Executive, a board of education, the Conseil scolaire fransaskois or a group established in accordance with Bylaw No. 8 are entitled to sponsor resolutions.

#### **Resolutions:**

1. Bylaw No. 12, Paragraph 4, states that resolutions are to be submitted to the Resolutions and Policy Development Committee "at least 30 days prior" to the commencement of the general meeting at which they will be voted on. This year the **deadline for submission** of **resolutions** is 4:30 p.m., <u>March 15, 2016</u>. Resolutions received by the deadline will be presented by the Committee at the Spring Assembly.

(Paragraph 5 of Bylaw No. 12 provides for submission of resolutions that "directly relate to a matter that has arisen after the deadline for submission" at least 5 days prior to the commencement of the general meeting.)

2. Every resolution is to **be in writing** and **accompanied by a rationale explaining the background and reasons for the resolution.** 

Pursuant to Resolution 5-E passed at the 2010 AGM, the Committee asks sponsors to provide, where applicable, a simple estimate of the anticipated cost and staff resources that would be required to act on the resolution.

5-E BE IT RESOLVED that from time to time when proposals for projects or services to be carried out by the Saskatchewan School Boards Association are put to member Boards for approval and those projects or services may have a cost and time component that will impact Association finances and staff time, it be required that all

such proposals put to member Boards for consideration include the cost and time requirements to conduct the project or provide the service.

- 3. The Committee will examine, edit, and, where considered necessary, combine similar resolutions.
- 4. The package of resolutions to be presented by the Committee at Spring Assembly will be e-mailed to boards, posted on the Association website no later than March 21, 2016 and included in the Spring Assembly registration package.
- 5. Resolutions provide directives for action to the Association by its members and direction for development of Association position statements. To increase the effectiveness of resolutions, the wording of a resolution should, whenever possible, describe what boards of education or the Association will do, rather than directing others, over whom the Association has no control, to act.
- 6. Resolutions received by the deadline will be presented at the Spring Assembly by the Committee. Any board that wishes to present a resolution after the deadline for submission will have to obtain the consent of the delegates at the Spring Assembly after all reported resolutions have been disposed of. (Bylaw No. 12, paragraph 6).

# **Prairie South Partnerships 2016**

### **Prairie South School Partnerships**

#### **Assiniboia Composite High School**

#### Assiniboia Conexus Credit Union

Conexus supplies volunteer power for school events (canteen, door workers, etc.) and their financial managers speak in classes (accounting, math, life transitions).

### Southland Cooperative Ltd.

The Southland Coop provides donations of food/supplies for many events and also provides sponsorship for many events. There is a building agreement with the shop classes at the high school. Their HR personnel guest speak in the CWEX classes and have provided mock interviews with feedback.

### **Assiniboia Elementary School**

#### Assiniboia Conexus Credit Union

This partnership is active, although not as active as it could be, so the school is currently working on it. Discussions and suggestions concerning Conexus are on the agenda for monthly school staff meetings. Conexus sends their staff members to assist during various events that the school has planned. The school knows that Conexus has more to offer and that the school should also be more actively reciprocating that support.

### Assiniboia 7<sup>th</sup> Avenue School

### Assiniboia Conexus Credit Union

Conexus Credit Union has joined us to support event such as Family Literacy Day. They have helped by providing volunteers to read with students and take part in the activities that are planned as part of the day.

#### **Avonlea School**

### Avonlea Heritage Museum

The Museum and the school coordinate an Old Fashioned school day for the grade 6's each June. We have also been displaying a new artifact each month in the school library. Students are involved in Museum cleanup when necessary. We have also gone on tours put on by the Museum Board for the Museum, Badlands and First Nations historical sites. Many of our classes go down for tours and we always support the Museum barbecue fundraisers.

### **Central Collegiate**

### Moose Jaw Exhibition Company Ltd.

Although this partnership has never really gotten off the ground, Scott is prepared to work with George Fowler at the Exhibition Company on making it a viable partnership.

### **Coronach School**

#### Hart Butte Community Farms Inc.

This partnership remains active. The school receives funding from Hart Butte in the form of \$500 scholarships to every graduation student pursuing any type of post-secondary education, as well as purchases such as the most recent 3-D printer. Students also go on field trips to learn about farming business.

# Westmoreland Coal Company-Poplar River Mine (formerly Sherritt Coal-Poplar River Mine)

This partnership is active. The school provides students for them (help with golf tournaments, suppers, etc.). Student art work is also provided. Their HR person conducts mock interviews for students in the CWEX program. The school also tours and provides support during Mining Week.

# **Empire School**

### **Moose Jaw Humane Society**

Students have fundraised on behalf of the Humane Society in years past, however there has been no involvement for the past few years.

#### RBC Royal Bank Main Branch

RBC has supported us in many different ways and they are a very valued partnership. This year RBC has contributed towards our library makeover. Their staff come regularly to read to our grade 1's as well as volunteer at our Book Fair, Family BBQ and Spookfest.

#### John Chisholm School

#### **Moose Jaw Conexus Credit Union**

Travis from Conexus Credit Union has been a welcome addition to the John Chisholm School Community Council. He attends monthly meetings and many special events, supporting the work of the SCC. He has been at the school the past two June celebrations to award the scholarship that they provide to a deserving student. Travis and Tanya have made one presentation on financial literacy to a family lunch this year. Conexus staff also supported us with delivery of the "Dollars Make Sense" program semester one this year. Our partnership relationship has effectively been reignited in the past year.

#### **Palliser Heights School**

### Pioneer Lodge

Although this partnership has become inactive in the last few years, this year the school has begun the process of re-establishing it. We will be partnering on some reading initiatives (students reading to residents), we have sent and will continue to send the choir and band over for performances. We have also presented the lodge with a Little Library.

### **Peacock Collegiate**

#### **Bombardier Aerospace**

This partnership may need to change since CAE has taken over servicing 15 Wing (Bombardier has moved out). Dustin will be approaching CAE regarding continuing the connection between our PAA programming and the aircraft maintenance department. The personnel in place at the base remain the same.

# **DynaIndustrial**

This partnership fluctuates between being very active and somewhat inactive. It involves Machining students working on projects for Dynalndustrial. There are currently no projects being completed. A group of students did recently travel to the business for a tour. Many students in the past have also participated in job shadows.

#### Tornado Hunter - Greg Johnson

This partnership was very active last year. It involved Peacock students building items for use in tornado hunting. There have been no discussions this fall and the partnership is currently inactive. In all likelihood, the partnership will end in the near future, but Dustin would prefer to leave it active for now. We have not collaborated in the last 1.5 years but do expect further coordination to occur.

#### Yara

This continues to be the most active partnership at Peacock. Yara assists in the interview process with the school CWEX program, participates regularly in a variety of school events including fundraising events, assists with job shadows, and sponsors two scholarships. In 2016, Yara and Peacock Collegiate will celebrate 20 years of partnership. A formal ceremony and reveal will take place in the fall of 2016.

#### **Prince Arthur School**

#### **Kiwanis Club**

Unfortunately the Kiwanis Club has folded due to a lack of membership. They did donate \$5000 to our playground project before they dissipated.

We have been working on a few informal partnerships. These include:

### **Moose Jaw Exhibition Company**

We met with them twice. The second meeting consisted of all our teachers doing a tour on our Jan 29th Prep day of the exhibition grounds. We are exploring how the Exhibition Company may enhance learning outcomes for our students.

#### **East Side Community Association**

President attends our SCC meetings regularly. Our school has conducted a community clean-up in conjunction with the East Side Community Association. We are also in the planning stages of planning an In Motion competition with the association. The association donated \$1000 for our new playground.

### Wakamow Aboriginal Community Association

Hosted a Round Dance in our gym for approximately 3-400 participants from all over Saskatchewan. We are in the planning stages for next year to host the dance at Prince Arthur.

### **Building Blocks Daycare**

Just started coming to our SCC meetings periodically. Exploring how we can support each other. They had their Christmas Concert in our gym and they also participated in our SCC Trade Show.

### **Riverview Collegiate**

#### **Canadian Mental Health Association**

Donna Bowyer is the Director of the Moose Jaw Branch of the Association. The CMHA does not have an office at Riverview anymore but the association is still actively involved in presentations and training experiences for RVCI students, participation in Education Week, and events like Challenges and Choices Day and Clara's Big Ride, which focus on mental health awareness.

### **Moose Jaw Humane Society**

The Humane Society provides many work placements, particularly for students in the Lifeskills program. Students also participate in fundraising events, such as "Paws for Pledges."

#### **Moose Jaw Transition House**

Lois Thomson, outreach worker for Transition House, has an office at Riverview. Students participate in the annual Grandmother Moon Symposium. Lois provides counselling support for students and is a member of the Riverview School Community Council (SCC).

#### Saskatchewan Wildlife Federation

The Federation provides much support for school programs, including the school archery club. Students participate in the Wildlife Expo, the Yellow Fish Road Program (learning about water supply and the impact on the community), and the Great Canadian Shoreline Clean-Up Program.

The partnership between Sunningdale and BMO continues to be active.
